MINUTES

25/65.	Welcome The Council noted the resignation of Cllr White and expressed appreciation for her contributions during her time on the Council. Election of a Chair Cllr Southern proposed Cllr Nelson which was seconded by Cllr Cranfield. Resolution: That Cllr S. Nelson be appointed as Chair.
25/66.	Apologies To receive apologies and consider accepting the reasons for absence. No apologies were received.
25/67.	Declarations of interest a. To receive and consider any declarations of interest not already declared under the Council's code of conduct or member's register of disclosable pecuniary interests. None b. To receive and consider upon any applications for dispensations. None

25/69.	Public participation Any resident may speak for up to 3 minutes on any matter on the agenda with the session lasting no longer than 20 minutes. A representative from Wheldrake Preschool attended to thank the Council for the recent grant award and presented a handmade card from the children.
25/70.	Co-option a. To consider applications from eligible residents for the vacant seat on Wheldrake Parish Council. None received b. To approve the co-option of an eligible councillor to the vacant seat and to receive the appropriate documentation. Not applicable
25/71.	Reports To receive reports from the following: a. Proper Officer to include CYC updates on councillors register of interest forms. The Clerk provided an update on outstanding issues: vegetation on Broad Highway has been reported, Highways have been contacted regarding fixed bollards at The Courtneys, the school confirmed the hedge will be cut as

	part of routine maintenance and some bordering trees have been trimmed. The new noticeboard has arrived and requires installation, which Cllr Myers will assess, and he will dispose of the old one. Discussions took place regarding the school trees overhanging the play park and the Parish Council's maintenance of land in the village owned by City of York Council or other landowners. Resolution: The Clerk to write to school highlighting concerns about overhanging trees and request that further work be carried out. The Clerk to establish ownership of land currently maintained by the Parish Council and report back to a future meeting. b. Ward Councillor The Council received and considered a written report from the Ward Councillor. Resolution: To support an application for ward funding to install hedgehog warning signs. c. Community Police Officer, including monthly crime statistics report The Council noted one incident of vehicle theft in the crime statistics report for August.
25/72.	Groups and Committees To receive and consider for decision reports and recommendations from: a. Playpark A discussion took place which included: • The park is currently closed, with a view to reopening at the end of next week. Chains had to be cut to gain access. Four additional padlocks have been purchased for benches, although the existing combination could have been reconfigured. • Antisocial behaviour within the tractor area and the recommended age limit. • New swings have been installed and are performing well. • Amendments to the current signage. Resolution: Cllr Nelson to draft wording for new signage, and Cllr Myers to arrange procurement and installation. b. Village Maintenance A discussion took place regarding Braithwaite Green, recent hedge cutting, and the responsibilities of City of York Council. The matter will be revisited under the resolution at item 71A. c. Defibrillators • All units in working order; replacement stickers received. • Industrial estate defibrillator to be relocated from Buckle Court, with the hairdressers offered as a possible site. • Pub defibrillator to be removed for refurbishment works on 7 October. Pub does not want it reinstalled in the current position, alternatives and electrician support to be explored. • Residents to be informed once a new location is confirmed. Resolution: The Clerk to write to the public house owner to agree a new location for the defibrillator. Cllr Elsey-Jeffree to contact an electrician to arrange the defibrillator relocation. d. Community speed watch • Activity has been limited since the last meeting due to various reasons. • Dates scheduled weekly until the end of November . e. WRA representative There has been little progress, with no response received from WRA to date. Concerns regarding a lack of transparency were noted. Efforts to make contact will continue.

	<u>Resolution:</u> The Clerk to arrange “Use at your own risk” signs for Sandholes Wood, to be placed both inside and outside the wood, with Cllr Surtees to install them in due course. c. To consider future maintenance on the land on Main Street, opposite the Church. A discussion took place regarding future maintenance of the land. The planters are the Parish Council’s responsibility. The land is a valued asset for the village. The Council did not rule out taking ownership of the land but would prefer that the landowner contributes to maintenance of both areas before offering this. <u>Resolution:</u> The Clerk to discuss options with the landowner and report back to a future meeting.
